Cessnock secures \$3.1 million in funding

Investing in education

The Electorate of Cessnock is set to get a childcare boost as Cessnock Multipurpose Children's Centre has been awarded \$3.1 million under the Major Capital Works Fund 2022-23, Strong Start Capital Works Grants Program.



In exciting news the centre which will be operational from 2025 will deliver 44 new licensed places for preschool aged children. The preschool will be located on the corner of Wollombi Road and Lochinvar Street, Bellbird Heights.

With the growing population in the Cessnock City LGA the news of funding for a new preschool to serve the area is fantastic and very welcome.

For our children to thrive we need to be investing in education, especially for our youngest citizens. The importance of early childhood education cannot be overestimated; it provides a foundation for education as children progress through their school days.

The Cessnock Multipurpose Children's Centre have been operating for over 60 years as a community based, not-for-profit organisation which offers long day care, preschool, occasional care, OOSH and vacation care. It currently employs over 100 people with an additional 6 positions to come when the new centre opens.

Any investment into the education of our children is an investment in their future.

Link Road roundabout Update

Transport for NSW (TfNSW) and developers have been having discussions about upgrades to the roundabout at Newcastle Link Road and Minmi Road including the possibility of the installation of traffic lights.

At a recent Hunter Central Coast Regional Planning Panel briefing, minutes refer to an agreement between TfNSW and the property group Winten, who are hoping to move forward with the massive Minmi residential development.

The agreement; whereby the developer is contributing to an upgrade to the intersection which is currently a roundabout to a more suitable arrangement. One option is traffic lights however TfNSW are continuing to work on a preferred option.

The planning panel had previously refused the development proposal due to traffic concerns.

The panel was told that the developer would enter into an agreement to contribute financially to convert the Link Road roundabout to an option that will be fit for future growth.

Transport for NSW have started a study to consider any potential changes to improve traffic flow and safety.

Greta Bus Crash

The NSW Government will be guided by the families, friends and those affected in regards to community memorials and/or wider services. I extend my sincere condolences and sympathies to every single person touched by this tragedy.

Committees and Hospital visits



Health has been front and centre of the new NSW Government and has been a key focus for myself in the Electorate.

In Parliament I am pleased to report I have been nominated to be a member of the Select Committee for Regional, Rural and Remote Health. The committee is following the implementation of 44 recommendations to improve heath outcomes for people in rural, regional and remote NSW.

In early July I had the pleasure to have the NSW Parliamentary Secretary for Health, Dr Michael Holland, MP visit our community to explore both Cessnock and Kurri Kurri Hospitals.

While there are plenty of challenges facing our hospitals, there are also some really exciting things happening as well.



In one of it's first acts as a new Government, the new NSW Labor Government have successfully protected Hunter Water and Sydney Water from privatisation through the passing of the Constitutional Amendment (Sydney Water and Hunter Water) Bill 2023.

The new legislation will protect Hunter Water and Sydney Water from being sold off to private interests.

The amendment to the Constitution Act 1902 safeguards public ownership of the state's most critical public water assets, which includes Hunter Water.

The bill ensured that this critical water infrastructure would continue to be operated with the best interests for the people of NSW, not in the interest of private profits.

Kurri Kurri Hospital **improvements**

Investing in health



One of the many fights I continually have for our Electorate is to keep services at Kurri Kurri Hospital. While the hospital does not operate as it once did when it opened many decades ago, it still provides many necessary services to our community.

The Kurri Kurri Rehab Unit is going from strength to strength with more staff recently hired and I have received some wonderful feedback about the service provided.

The hospital has an operating theatre which is constantly in use for a large number of surgeries.

The hospital also supports a number of outreach community services which function from some of the hospital's many buildings.

Kurri Kurri Hospital has also received important upgrades with Hunter New England Health recently securing funding for a new roof with solar panels for the hospital.

Air conditioning at the hospital has recently been upgraded as well as increased security measures installed including a dedicated staff parking space within the facility and swipe card access to the

It is great to see funding being allocated to Kurri Kurri Hospital.

New **Ambulance Station**



Ambulance proposed Station for the Branxton, Greta, Huntlee and North Rothbury communities is a step closer as public calls have been made to find suitable land for the new Ambulance Station.

The new station which was announced in March 2023 will feature internal parking for emergency ambulance vehicles, vehicle wash facilities, parking, multipurpose spaces to support staff education and rest, logistics and storage areas, and office administration areas as well as staff amenities.

The new ambulance station which was earmarked with several others across the Hunter is being delivered as part of the \$615.5 million NSW Ambulance İnfrastructure Program.

Heddon Greta traffic lights completed



The Heddon Greta traffic lights were completed at the start of May. It has taken some time with multiple delays, however it is fantastic to see the traffic lights at the Heddon Street intersection in operation.

With the upgrade completed it is a win for residents and motorists and provides an important improvement in safety for the community.



The completed upgrade includes the new traffic lights at the Main Road intersection with 2 lanes in each direction through the intersection for better traffic flow and increased safety.

'No stopping' signs have been installed around the intersection, as well as peak period restrictions in front of businesses between Stanford Street and Heddon Street. Transport for NSW have also installed a new roadside safety barrier which will help with preventing motorists from veering off the road and a cycle lane has been added to assist cyclists with travelling safely through the intersection.

This upgrade will assist with reducing the risk of crashes by redirecting motorists entering and leaving Main Road to the new traffic lights at the Heddon Street intersection.

First home buyers save on stamp duty

Investing in housing

Thousands of first home buyers will no longer have to pay stamp duty as the new NSW Government has implemented a new First Home Buyers Assistance Scheme. The updated scheme which came into effect on 1 July has moved the threshold for stamp duty exemptions from \$650,000 up to \$800,000 and the threshold for stamp duty concessions from \$800,000 to \$1 million.

What this means is that first home buyers who purchase a home up to \$800,000 will pay no stamp duty at all.

In the Cessnock Electorate, this will lead to an average saving of \$21,190. These changes will help 5 out of 6 first home buyers in NSW to pay no stamp duty, or at a concessional rate, and delivers a key election commitment.

The changes to stamp duty will allow thousands of first home buyers to enter the market sooner and give them a boost when competing with other buyers.



Over 7,000 positions made permanent

Investing in education

The new NSW Labor Government have made changes to fix the education system. As of the end of June 2023 over 7,000 teachers and support staff have been made permanent.

Before the state election in March 2023 nearly 40% of the public school teaching workforce were either temporary or casual employees. That is thousands and thousands of teachers not having stability in their jobs, resulting in teacher shortages and a mass exodus of teachers from the profession.

The Minns Government made the election commitment to transfer 16,000 temporary teaching and support staff roles to permanent positions.

We have been making good on this promise with over 7,000 staff already accepting permanent roles and this number is growing everyday.

A majority of the 7,000 positions have been accepted in rural and regional areas. In Newcastle and the Hunter region 1,800 permanent positions have been accepted.

It is important for the education of our kids that teachers are supported and feel secure in their jobs.

Energy Bill Relief Assistance Scheme

The NSW and Federal Governments have worked together to provide targeted temporary energy bill relief. Eligible households will receive \$500 in energy bill relief and \$650 for small businesses from 1 July.



The Energy Bill Relief Fund will provide support to 1.6 million eligible NSW household and 320,000 eligible NSW small businesses.

This relief includes funding from both governments which include \$485 million from the NSW Government and \$481 million from the Federal Government.

The relief is available to households eligible for the:

- Senior Energy Rebate Low-income Household (electricity) Rebate
- Family Energy Rebate
- Medical Energy Rebate
- Life Support Rebate

Most eligible households and small businesses will automatically receive the Energy Bill Relief after 31 July 2023. This will be a household rebate of \$125 quarterly directly off energy bills.

State finances in massive debt

With a change in Government at the March 2023 election, concerns I have long held about the state of the budget are now being revealed, for all to see.

When the Liberal/National Government came into power in 2011 they inherited just \$22.5 billion or \$3,100 per person in borrowings. Today that figure has blown out massively to \$129 billion and projected to be \$187 billion or \$22,000 per person by 2026. This is the largest debt ever handed from one government to another in NSW history.

In addition to these massive borrowings a further \$100 billion of our state's assets were sold off - and all of that money has now been spent. Historically assets would generate income for our state ie electricity network, tolls etc. Without these assets, they are no longer bringing in money to pay back the debt of the borrowings.

The cost of interest on the amount borrowed is \$7 billion per year. That equates to \$134 million a week, more than \$19 million per day - just in interest payments. How significant this is cannot be overestimated; \$7 billion is bigger than the total budget for the NSW Police and TAFE combined.

That \$134 million interest per week could have been used for building a new school each week, or a massive hospital upgrade each week, or new major road upgrades each week.

Completely unrelated to the \$7 billion per year in interest payments, after the change in Government, Treasury briefs uncovered a \$7 billion 'black hole'.

This budget 'black hole' includes several programs the previous Government had failed to take into account in the budget - including active kids and creative kids vouchers, \$100 million per year cut from Destinations NSW budget, \$700 million funding shortfall for kids living in out-of-home care and 1,100 nurses who are unfunded from 30 June 2024.

With the damage to the state's finances, \$7 billion budget 'black hole' and a hospital and education system in crisis, we have a very big job to turn things around. The new Minns NSW Government are taking action to control expenses and that means making tough decisions, that won't always be popular, to try to repair the budget.

Cessnock Hospital redevelopment update

Investing in health

The redevelopment of Cessnock Hospital is in full swing with plans being updated prior to further community consultation.

At a recent briefing held with Hunter New England Health I had the opportunity to see the current redevelopment plans for the hospital.

The Cessnock Electorate secured \$111.5 million for a major redevelopment of the current hospital which was announced in 2021.

Round 1 of community consultation has been held to show the plans for the redevelopment and for the community to provide feedback.

At the time of publication Hunter New England Health are scheduling a second round of consultation so the community can view the amended plans.

The redevelopment of the hospital will see a new two storey building built on the current site and more parking at the hospital.

Some buildings which were scheduled for demolition may have to stay due to the cost of tearing them down, however this will not impact the new building.

Huntlee High School update



A new high school to serve the growing communities in the North Rothbury, Greta, Branxton and Huntlee areas is getting closer.

During the 2023 State Election now Deputy Premier and Minister for Education, Prue Car MP announced if Labor were elected to govern we would start immediate planning for a high school in the area.

Since coming into government the Department of Education has been instructed to begin conversations with the LWP Property Group (developer of Huntlee) about the site for the high school.

It is pleasing to see initial steps being taken to secure the site and planning.

Justice of the Peace services available

New App to help Domestic Violence Victims

NSW Police have launched a new app which allows for victims of domestic and family violence in NSW to discreetly document abuse and access support services. The app is part of the Domestic and Family Violence Reform Project which was established to change the way police respond to and prevent domestic violence.


The 'Empower You' app was designed to be user friendly, with privacy features including passcodes and quick lock, along with a diary feature that allows users to document incidents.

The app includes a private diary, a coded emergency signal feature which can also send their GPS location, simple connectivity to Triple Zero (000) for emergencies, and links to local support services.

The diary feature allows a victim to collect their thoughts - including photos of injuries and property damage and screenshots of emails or messages, and document an incident when it happens.

The 'Empower You' app is available in the Google Play Store and the Apple App store. NSW Police officers have QR codes on their MobiPOL devices to link to the app and download information.
